La Embajada de Su Majestad Británica en Madrid saluda atentamente al Ministerio de Asuntos Exteriores, Unión Europea y de Cooperación de España y, tiene el honor de comunicar que a partir del 30 de marzo de 2019 el Reino Unido empieza a expedir tarjetas de estacionamiento para personas con discapacidad "distintivo azul" con un nuevo formato un poco diferente. Se adjunta un ejemplar del modelo nuevo. Esto significa que durante un plazo de tiempo, existirán dos modelos distintos al mismo tiempo.


El Gobierno del Reino Unido continuará a reconocer las tarjetas de aparcamiento para personas con discapacidad expedidos en la Unión Europea cuando visitan el Reino Unido. Esta política refleja la implementación de la Recomendación del Consejo sobre una Tarjeta de Estacionamiento para personas con discapacidad (98/376/EC). La Embajada ruega que el Gobierno de España continúe a ofrecer el mismo nivel de reciprocidad sobre el nivel actual de reconocimiento de los ciudadanos del Reino Unido titulares de las tarjetas distintivo azul que visitan España y que les ofrezcan concesiones similares de estacionamiento.

En el modelo nuevo las estrellas de la UE en la parte delantera y en el holograma han sido eliminadas. Las letras "UK" cambian de color de amarillo a blanco.

La Embajada de Su Majestad Británica aprovecha esta oportunidad para reiterar al Ministerio de Asuntos Exteriores, Unión Europa y Cooperación de España el testimonio de su más alta consideración.



The new UK badge sees the removal of all appearances of the EU stars from the printed badge face and the hologram; and changes "UK" on the front of the badge from yellow to white. Otherwise, the badge will be no different from the current badge so as to facilitate continued mutual recognition with EU Member States.

Redesign of the UK Blue Badge

As of 30 March 2019, the UK will begin issuing Blue Badges in a slightly different form. This will mean that, for a period of time, there will be two different styles of the UK badge in circulation at the same time. The badges are shown below.




